ORDER TO EXTEND  
SETTLEMENT AGREEMENT

The parties to this matter jointly move the Court for an order extending the original Settlement Agreement (adopted by the parties on July 31, 2004, and approved by the Court on November 9, 2004) from its current expiration date of July 31, 2011 to October 31, 2011.

The original Settlement Agreement provides that it shall remain in force for a period of 84 months from the date it was executed unless an enforcement action is pending. The 84 month period expires on July 31, 2011. This Court retains jurisdiction over the above referenced matter. This Court further heard and determined Plaintiffs' motion to enforce the Settlement Agreement in June, 2008, and entered an Order on said motion on September 24, 2008.

1 Since November 2010 the parties have been meeting regularly in an attempt to  
2 negotiate an agreed extension and/or revision of the Settlement Agreement. Both  
3 parties agree that additional time is necessary if negotiations are to prove successful.  
4 In order to continue the negotiation process, the parties mutually move this Court for  
5 entry of an order extending the original Settlement Agreement for an additional three  
6 months from its scheduled expiration date of July 31, 2011 to October 31, 2011. The  
7 parties further agree that all provisions of the current Settlement Agreement, as well  
8 as the provisions of any and all orders entered by this Court in this cause subsequent  
9 to July 31, 2004, will remain in full force and effect during this period.

11 Based upon the foregoing, the Court hereby **ORDERS:**

12 The original Settlement Agreement (adopted by the parties on July 31, 2004,  
13 and approved by the Court on November 9, 2004) is extended for an additional three  
14 months from its scheduled expiration date of July 31, 2011 until October 31, 2011.  
15 All provisions of the current Settlement Agreement as well as any and all orders  
16 entered by this Court in this cause subsequent to July 31, 2004, remain in full force  
17 and effect during this period.
