2008 Survey Reports

This is one of three separate documents that present aspects of the 2008 Survey of youth in foster care in Washington State. Below is a brief description of the contents of each report:

- **Youth Age 17.5 & Older Survey Outcomes Report 08-042**

This report presents an introduction to the purpose of the survey, provides an overview of the survey methods, describes the calculation of the Braam Panel outcome for which the youth survey is the data source, and presents the survey results for every question in the survey for all youth age 17.5 and older participating in the survey.

This report presents an introduction to the purpose of the survey, a detailed description of the survey methods and survey results and includes a copy of the telephone interview questionnaire, the letter mailed to youth and to foster parents and other survey materials. This report includes the final sample disposition, and the results for every question in the survey for all youth age 15 to 18 participating in the survey. This report also describes the qualitative results obtained from three discussion groups held with youth in Yakima, Seattle, and Tri-Cities.

Abstract: *This report presents the results of the survey of youth in foster care, but only for those 182 youth who were 17 and a half years old or older at the time of the interview. (For the full survey results see SESRC Data Report # 08-038).* The SESRC was contracted to design and conduct an independent, statistically valid, anonymous telephone survey of youth, age 15 to 18, in foster care in Washington State. The main purpose of the survey is to obtain information that will help Children's Administration improve services for adolescents in foster care (including placement with relatives). Another purpose is to provide data to the Braam Oversight Panel to measure a benchmark established by the Panel under the Braam Settlement Agreement. In developing the survey design, questionnaire, and procedures, the SESRC consulted with the Braam Oversight Panel, the Children's Administration (CA), and plaintiffs' attorneys. The telephone survey began on March 17, 2008 and continued through July 15, 2008. Contact was attempted with the entire population of 1679 adolescents age 15 to 18 in foster care in Washington State in the custody of CA in 2007. A total of 706 interviews were conducted by telephone. SESRC also conducted discussions with three groups of youth who were or had been in foster care to obtain additional information about their experiences. Discussion groups were conducted in June 2008 with youth attending Independent Living programs in Seattle, Tri-Cities, and Yakima.

Method: The study protocol for the telephone survey included mailing an introductory letter to 1679 foster parents of youth and an introductory letter to 1679 youth prior to the start of the telephone calling. Telephone calls began on March 17, 2008 and continued through July 15, 2008. Telephone interviews were conducted using a computer assisted telephone interview (CATI) system, and a call scheduler to ensure that up to 12 call attempts were made to reach each youth. The telephone interview averaged 26 minutes to complete.

Results: The SESRC obtained 698 interviews and 8 partially completed interviews over the 18-week calling period. The cooperation rate for the telephone survey was 80%. The overall response rate was 42%. There is no sample error, since the entire population of youth, age 15 to 18, in foster care was included in the survey.

SURVEY DESIGN

Study Background and Survey Objectives

The SESRC designed and conducted an independent, statistically valid, anonymous telephone survey of youth age 15 to 18 in foster care during 2007 in Washington State. In addition, the SESRC conducted discussions with three groups of youth participating in Independent Living programs in Seattle, Yakima, and Tri-Cities to obtain additional information about their experiences in foster care. The survey and discussion groups were conducted in 2008 and asked adolescents about their experiences during calendar year 2007.

The main purpose of the survey and discussion groups is to obtain information that is helpful to Children’s Administration efforts to improve services to youth in foster care. The survey includes questions on placements in foster homes, interactions with social workers, awareness of and experiences with services to adolescents, life experiences related to sibling relationships, significant adults, school, physical safety, running away and homelessness; and issues related to aging out of the foster care system.

In developing the survey design, questionnaire, and procedures, the SESRC collaborated with a working group consisting of representatives of the Braam Oversight Panel, Children’s Administration (CA) staff, and Braam plaintiffs’ attorneys. The survey questionnaire was extensively reviewed by foster youth, Braam Panel members, Children’s Administration staff, and Braam plaintiffs’ attorneys, to ensure that it would provide adequate information

Population and Sample

The population for this survey is described as “all youth ages 15 to 18 who had a current placement episode at the time the sample was drawn, and have been in foster care 60 days or longer, excluding guardianships and VPAs (voluntary placement agreements).” Table 1 below displays the population as of the March 2008 administrative record file maintained by DSHS. Since the entire population of eligible youth was included in the survey there is no sample error in the survey. Table 2 below shows the number of interviews that were completed by region and age categories.

SURVEY IMPLEMENTATION AND PROCEDURES

Survey Procedures

Several procedures were implemented that helped to build a rapport with respondents and to ensure that respondents felt comfortable with the survey. Information about the survey was placed on the BRAAM website just as the survey data collection period was getting underway. Advance letters were sent approximately three to four days before the beginning of telephone interviews. First, an advance letter was sent to the 1679 foster parents to inform them about the survey of youth in foster care and explain more about the purpose of the survey and who was supporting it. About two days after the foster parent letters were mailed, each of the youth being asked to participate in the telephone survey was sent a personalized letter informing them about the purpose of the survey and that they would be called by an SESRC interviewer. The letters provided a toll-free 800-telephone number that youth (or their foster parents) could call in order to ask questions about the survey. This toll-free number was maintained throughout the calling period. The letter also explained that youth participating in the survey would have their names entered into a drawing for one of 18 cash gifts of \$100 each (three per region).

The SESRC telephone Interviewers were provided with a "Frequently Asked Questions" reference sheet to help answer questions that youth and foster parents may have about the survey. A toll-free 800-telephone number that foster parents could call in to ask questions about the survey was maintained during the calling period.

A particular concern for this survey was to put in place safeguards to guarantee confidentiality of survey responses and anonymity in survey results. To ensure that survey respondents cannot be identified from their survey responses the SESRC follows federal guidelines for protection of human subjects and maintains the survey dataset in a secure location at SESRC.

Telephone Interviews. The calling on the survey commenced after training of interviewers on March 17, 2008 and continued through July 15, 2008. The average number of call attempts across all cases was 12. Call attempts were made at different times of the day and on different days of the week in order to maximize the likelihood of reaching respondents. At least 3 evening call attempts were made and two daytime call attempts. At least one call attempt was made on the weekend. If an interviewer called at an inconvenient time for the respondent, the interviewer attempted to schedule a specific time to re-contact the household for an interview. If an answering machine was encountered, interviewers were instructed to leave a scripted answering machine message. If an answering message was left, the phone number was held for three days and then called on again. Only one answering machine message was left for each phone number. At the time of the interviewer's call the youth respondent could request being called back at a different time and/or at a different telephone number.

A total of 11,200 calls were made during the calling period in order to conduct the interviews. The average length for a completed interview was 26 minutes. Interviewers made an average of sixteen calls per hour during the calling period and one interview was completed every hour on average.

Response Rates

Of the 1,679 youth in the population of those that were in foster care in 2007, a total of 706 participated in the survey for a cooperation rate of 80% and a response rate of 42%. The cooperation rate indicates the percent of people who are contacted for an interview that agree to participate in the survey. The response rate indicates the percent of people in the total sample, minus the ineligible respondents, that participate in the survey. The calculation of both measures is based on the suggested definitions and procedures defined by the American Association for Public Opinion Research (AAPOR).

During the survey period there were some youth who could not be contacted because their telephone numbers were disconnected or nonworking, and no other number could be obtained. SESRC twice provided these numbers to Children's Administration for updated information. By the end of the survey, a total of 290 youth could never be contacted because the telephone numbers were disconnected and no other number could be obtained during the survey period. Many of these youth were 18 or older, and had left care, and no updated information was available for them.

Only 173 people refused to participate in the survey, and four were counted ineligible because the respondent said they had not been in foster care in 2007. Another 277 did not answer the phone or were not contactable because of an answering machine. Another 226 youth could not be interviewed for a variety of reasons including: turned 18 and left care, ran away from their placement, were in jail or detention, moved to a new placement, moved back to their birth family, were in treatment, or were physically or mentally unable to participate.

The cooperation rate and the response rate achieved in this study are somewhat higher than what is generally achieved in public opinion surveys. These high rates reflect what our telephone interviewers experienced in conducting the telephone interviews - that these youth were interested in participating in the survey and in offering their views on the issues addressed in the survey. The high cooperation and response rate are also due to the efforts of the SESRC data collection supervisors and interviewers in contacting respondents at various times throughout the day and on various days throughout the week during the survey period to ensure that people who were not at home would still have an opportunity to participate in the survey.

This high response rate ensures that the survey results are truly representative of the population of all youth age 15 to 18 who are in foster care in Washington State.

SURVEY RESULTS

The survey results presented in this report are only for the 182 youth who were 17 and a half years or older at the time of the interview. The first section of these results presents the results for the Braam outcome question (Q99), and the remaining section presents the results of all the survey questions for these 182 youth age 17 and a half and older.

A note about the difference between "percent" and "valid percent" in the tables that follow. The survey result tables show two different percent values that differ in how the missing values and skips are included in the calculation of the percentages. The "**percent**" column includes the missing and skips in the calculation. The "**valid percent**" does not include missing and skipped values in the calculation. In most instances, the "valid percent" is the most appropriate measure to use, since this shows the percent of only those youth that answered the question.

Braam Outcome Calculation

The adolescent survey is expected to serve as the data source for **one** Braam outcome related to preparation for independence. The Panel and parties have agreed that in the revised Implementation Plan, this outcome will address only multi-disciplinary staffings for youth six months before exit.

This question is screened to exclude youth who are less than 17.5 years of age at the time of the interview (birth date variable is Q19-N; and interview date is included in the survey dataset).

A variable was created based on the difference between the date of birth of the youth and the date of the interview. This variable was used to screen youth into one of two groups: youth who were less than 17 and a half years of age at the time of the interview, and those who were older. Of the 706 youth participating in the survey, a total of 182 youth were 17 and a half years of age or older at the time of the interview.

The overall Braam outcome for Q99 is 38%. This indicates that 38% of eligible youth in foster care (those age 17 and a half or older) said they were invited to a shared planning meeting to discuss their transition from foster care.

The regions vary in the Braam outcome measure from a low of 33% in region six (Olympic Peninsula) to a high of 47% in region one (Spokane).

Summary of Survey Results for Youth Age 17.5 and Older

The survey results presented in this report are only for those foster care youth who were 17 and a half years old at the time of the interview. These survey results are generalizable only to those youth in foster care in Washington State who are 17 and half years old or older. This summary is organized by question topic, and largely follows the question sequence of the interview.

Placement

- The median number of years spent in foster care, including relative placements, for these youth is six years.
- 59% of these youth were in the same placement for all of 2007; 22% were in two placements in 2007.
- Youth behavior problems, problems in the family, and not getting along in the placement accounted for 55% of the reasons that youth were moved to different placements in 2007.
- The median number of different placements experienced by these youth during their entire years in foster care is four. However, 20% of these youth reported having more than 10 different placements during their years in foster care.
- 58% of these youth were in a foster home during 2007, and 18% were living with relatives.
- Their current placement was headed by dual parents for 71% of these youth.
- The majority of these youth were in placements with two or fewer other children living there. For 21% they were the only child in the placement; for 20% there was one other child; and for 14% there were two other children present.
- Almost 24% of these youth had lived three or more years at this placement, and 44% had lived there for 12 months or less.
- 52% of these youth said that the foster care system had treated them very well in 2007; 34% said somewhat well; and 14% said not very well.
- Asked for the main reason that they felt the way they did about the foster care system, the dominant positive reason given by 21% of these youth was that they got lots of help and were well taken care of and supported. The dominant negative reason given by almost 10% of youth was they didn't like being in foster care, and didn't feel that they were supported.
- Asked how they felt about their current placement, almost 70% said very positive.
- 80% of these youth said that they were very or somewhat involved in their case planning in 2007.

School

- 45% of these youth said they received mostly A's, B's or A's and B's in 2007. Another 30% said they received mostly B's and C's.

- 23% of these youth said that they were suspended or expelled from school during 2007.
- About 67% of these youth say that they hope to achieve an associate's degree or higher in the future.
- 89% say that they are very well prepared or somewhat prepared to achieve their educational goals.
- 78% of these youth have heard of and IEP or 504 Plan, and of these 56% have an Individual Education Plan now (43% of all youth age 17.5 and older).
- Among these youth who are knowledgeable about IEPs, 61% say they have attended an IEP meeting, and of these, 42% said that their social worker attended the most recent meeting with them.

Runaways/Homelessness

- Almost 25% of these youth said that they ran away from their placement in 2007. Of those that ran away, most only ran away once (41%) or twice (20%).
- The majority of those that ran away stayed with a friend (64%). The dominant reasons given for running away were that they didn't get along with the foster parents or family, and/or didn't like the placement or the way they were treated there.

Significant adult relationships

- 79% of these youth said they had contact with an adult member of their biological family in 2007.
- For those that did not have such contact in 2007, 46% said this was by choice, and 54% said it was not possible to arrange contact.
- For those that did have such contact in 2007, 34% said they were in contact a few times a week, 8% said about once a week, and 27% said a few times a month. 54% of these youth said this was the right amount of contact, and 40% said they would have preferred more contact.
- Asked if there was one adult that has had an important positive influence on their life currently, 84% of youth said yes. Asked how this person was related to them, 29% said it was a foster parent, 13% said a grandparent, and 12% said another relative.
- 90% of these youth said that there is definitely or probably someone in whom they can confide or talk to.
- Asked who they go to first when they have a problem, almost 28% of these youth said foster parents, and 24% said friends.

Health/Mental Health Services

- 91% of these youth said their health was excellent, very good, or good.
- Almost 83% said they had had a physical examination by a doctor less than a year ago. 86% said they had a dental examination less than a year ago.

- Slightly over 10% of these youth said that there were times in 2007 when they thought they needed medical care but didn't get it.
- 41% of these youth are currently seeing a psychological counselor, psychiatrist, or therapist. 53% have been seeing this person for more than one year. 54% said that this has been very helpful to them, and 32% said it has been somewhat helpful.
- Almost 60% of these youth seeing a therapist said there was no change in whom they were seeing during 2007. For those whose therapists changed in 2007, the dominant reasons for this were due to a change in placement (52%) and that the therapist decided to leave (30%).
- 11% of these youth said that there were times in 2007 when they thought they needed counseling or therapy but didn't get it. The main reasons given were for depression and sadness, help with problems and issues, and needing to talk with someone. The main reason given for not getting the needed therapy or counseling (by almost 32%) was not following through to ask for it.
- 17% of these youth said they have had an assessment or counseling related to alcohol or drug abuse in 2007.

Social Worker

- The median number of social workers that these youth have had since they've been in foster care is three.
- 90% know their current social worker's name, and 95% know how to contact them. Almost 50% of these youth communicate with their social worker at least once a month. 53% know how to contact their social worker after hours or on weekends.
- Over 36% of these youth have a face-to-face visit with their social worker at least once a month. 89% of these visits were at the youth's placement.
- 48% of these youth are very satisfied with the quality of support provided by their social worker, and 27% are somewhat satisfied. 25% are dissatisfied.

Sibling Relations

- 93% of these youth have biological siblings, and for most (79%) their siblings are not living with them.
- 50% of these youth with siblings not living with them have visits and other forms of contact with their siblings at least once a month or more often.
- For those that have the least contact with their siblings, a main reason is that the siblings live far away, or are in another state (32%).

Court Awareness

- 41% of these youth have a Guardian Ad Litem. 74% of these youth say they are represented by an attorney.
- 77% of these youth say that their wishes and interests were heard in court in 2007.
- Asked how often they were notified in advance about upcoming dependency court hearings, 40% of these youth said always, and 20% said most of the time.

- 33% of these youth attended no dependency court hearings in 2007, and 23% attended three or more.
- 40% of these youth did not miss any dependency court hearings that they were aware of, and 21% missed three or more.
- Over 81% of these youth say that they were advised as to the results of court hearings in 2007, including the ones they missed.

Service Awareness

- Only 37% of these youth had ever heard of the Educational Advocacy program.
- 73% of these youth had heard about the Foster Care to College Mentoring program or the Treehouse Coaching to College program.
- 52% of these youth had heard about the “you-can-go-to-college” or the “foster care to college” workshops put on by Independent Living providers.
- 57% of youth had heard of the Make-It-Happen summer college experience program.

Job Opportunities

- 30% of these youth are currently working for pay. And, 66% have ever worked for pay.
- Among those who have not ever worked for pay, 60% said that they wanted to work but couldn't find any paying jobs.
- 71% of these youth said that they are currently looking for work.
- 87% of these youth said that their caregivers were supportive of their efforts to look for work. Less than 2% said they were not supportive.
- 47% of these youth say they feel very well prepared to get a full time job, and 38% feel they are somewhat prepared.

Independent Living

- 70% of these youth say that a social worker referred them to an IL or TL program. 53% of these youth say they have ever participated in an Independent Living or a Transitional Living program.
- Among those who have not participated in these programs the main reasons given for not participating include not knowing about them (29%), being too busy with school or work (19%), and not needing it or wanting it (15%).
- 45% of these youth say they completed a life skills assessment such as the Ansell Casey Life Skills Assessment in 2007. 72% of these youth said that their social worker reviewed the results with them.
- 55% of these youth said that their social worker or IL provider invited them to develop an Independent Living plan. Among these, 86% said they did participate in developing this IL plan.

- Asked how well their IL plan would help in making the transition to adulthood, among those with an IL plan, 49% said very well and 50% said somewhat well.
- Youth were asked whether they had received any information or training about 11 skills needed for independent living. The table below displays the percent of these youth that responded “yes” to these skills.

Youth Aging Out Plans (asked only of youth age 17 and a half or older)

- 38% of these youth say that they have ever been invited to a shared planning meeting to discuss their transition from foster care. Among these youth, 70% said the meeting had already taken place. And, 94% of youth invited to a planning meeting said that they had participated or will be participating in this shared planning meeting.
- 47% of these youth said that they had talked with their social worker or their IL provider about developing a transition plan for their exit from foster care.
- 42% of these youth said that they participated in developing a transition plan.
- 22% of these youth said they have a written plan for transition from foster care.
- Youth were asked about five specific aspects of things needed for independent living. The table below displays the percent of these youth that responded “yes” to each of these.

- Asked how prepared they are to live on their own, only 27% said very prepared, and 51% said somewhat prepared. 22% said they felt not very or not at all prepared.

Physical Safety questions

- Youth were asked if there was any time in 2007 when another person at their placement made them feel physically unsafe. 8% of these youth responded "yes."
- In the majority of these instances (53%), the person that made the youth feel unsafe was another youth. But, for a third of these youth, it was a foster parent.
- The main reason given for feeling unsafe (60%) was that the youth felt threatened. 87% of these youth said they told their social worker about the incident.
- Two of these youth asked to be contacted, and their information was forwarded to Children's Administration for followup immediately following the interview.

Demographic questions

- Youth were asked how optimistic they were about their future. 55% of these youth said they were very optimistic, and 37% said they were fairly optimistic. Only 8% said they were not too optimistic.
- 53% of these youth are male, and 47% are female.
- 96% of these youth were born in the United States.
- 71% of these youth live on the west side of the state, 24% live on the east side, and 5% are out-of-state.
- The majority of these youth live in a small town (42%) or an urban area (36%).
- Asked to identify their ethnic background 5% say they are Native American, 13% Black, 2% Asian, Hawaiian, and Aleut, 7% Hispanic, 57% White, and 16% of mixed ethnic backgrounds. Separately a total of 14% of these youth say they are of Hispanic background.
- 87% have a computer in their placement. Of these, 85% have Internet access in their placement.
- 95% of these youth say they know their sexual orientation, and the same percent believes that their foster parents know as well.
- 85% of these youth identified themselves as heterosexual, 4% said they were homosexual, 7% said they were bisexual, and no one identified themselves as transgender.
- About 2% of these youth indicated that their sexual orientation had created problems for them in their placement. The main problems mentioned dealt with problems at school, harassment, and not being accepted by others.
- One of these youth asked to be contacted, and this person's information was forwarded to Children's Administration for followup immediately following the interview.

APPENDIX

A note about the difference between "percent" and "valid percent" in the tables that follow.

The survey result tables show two different percent values that differ in how the missing values and skips are included in the calculation of the percentages.

The "**percent**" column includes the missing and skips in the calculation.

The "**valid percent**" does not include missing and skipped values in the calculation

In most instances, the "valid percent" is the most appropriate measure to use, since this shows the percent of only those youth who answered the question.

There are three kinds of "**missing**" values reported for survey questions:

- Don't Know – when a youth responds with "don't know"
- Refused – when a youth says they don't want to answer
- System – refers to missing values that occur because of instructions in the survey to skip certain questions that don't apply to all respondents
